Notice To Customers:

This agreement and contract made and entered into on the date below, between Morris Outdoors Taxidermy, hereinafter referred to as Taxidermist, and the undersigned, hereinafter referred to as the Buyer, is agreed to and accepted by both parties as follows:

- A. Taxidermist agrees to perform the contracted work on the specimen, in a workmanlike manner by using current, efficient and effective techniques of taxidermy.
- B. Taxidermist DOES NOT guarantee any completion times, as these are just estimates. There are many factors out of our control that can effect completion times.
- C. The Buyer agrees to pay the required 50% deposit upon the execution of the agreement. If deposit is not paid within 30 days, Taxidermist reserves the right to charge \$5/day storage fees and/or sell the specimen to recover costs and labor fees. Hides will not be sent to tannery and no work will begin until AFTER the deposit is paid.
- D. In the event the specimen is not fully paid for within thirty (30) days after notification of its completion by Taxidermist, Buyer hereby agrees that the 50% deposit shall be considered earned by the Taxidermist and retained to defray a portion of his services. At this point, Buyer also authorizes Taxidermist to sell the completed specimen and retain the sales proceeds as fully earned monies.
- E. Seller will notify Taxidermist of specimen completion by telephone and/or standard mail service. Twenty-one (21) days after the notification date of specimen completion, a storage charge of \$5/day will be accessed.
- F. Excessively damaged specimen(s) (excessive cuts, holes, hair slippage, spoilage, etc.) will be subject to an additional damaged trophy charge which will be added to invoice in addition to agree upon charges. We will not be held responsible for damage to specimen(s) or hides due to improper field care, which will be determined at Taxidermist's discretion.
- G. All tanning is done at the Buyer's risk. Taxidermist makes NO guarantees for ANY tanning. Tanning must be paid in full at the time the specimen is dropped off. We will not be held responsible for any damages or loss of specimen(s) caused by the Tannery. In the event that damage or loss occurs at Tannery, Buyer agrees that full payment shall be considered earned by the Taxidermist and retained to offset costs and labor.
- H. Taxidermist shall not be responsible for damage or loss due to fire, flood, theft, Acts of God, war or any other conditions over which Taxidermist has no control.
- I. Final payment must be made by Cash, Cashiers Check, Personal or Business Checks.
- J. Any and all form alterations will be based on cost of materials plus time spent on labor (based on current shop rates). This cost will not be reflected in this invoice and will be added to the balance due at time trophy is picked up.
- K. If Buyer authorizes Taxidermist to pick up specimen(s) at processor or any other location, or if specimen is brought in by somebody other than Buyer, then all items on this contract are considered signed and valid. Buyer is still responsible for all occurring charges and all agreements listed above still apply.
